Mayor Allen Simmonds called the meeting to order at 7:00 PM. Council present Keith Hinds, Jonathan Erb, Sue Kelly; Absent Darlene Fuller.

Motion by S Kelly seconded by J Erb to approve the agenda. All ayes, motion carried.

Motion by J Erb seconded by S Kelly to approve the consent agenda. All ayes, motion carried.

Motion by J Erb seconded by S Kelly to approve the hiring of Mathew Cooper at \$10.25/hr, Jordan Miles at \$7.50/hr and David Osborne at \$7.50/hr for the temporary summer mowing positions. All ayes, motion carried.

Motion by S Kelly seconded J Erb to approve the buy out on the 72" John Deere Mower from AgriVision at a cost of \$2775.76; lease a 60" mower from AgriVision at a cost of \$193.40/month for 36 months and to lease a 60" Kohler from Leon Hardware at a cost of \$279.37/month for 36 months. All ayes, motion carried.

Motion by S Kelly seconded by K Hinds to approve naming Miller Insurance Agency owned by Shon Kofoid as our agent on record for employee health insurance. All ayes, motion carried.

Motion by J Erb seconded by S Kelly to approve Ordinance 2018-1 instilling a registration fee for the use of ATV's, UTV's and Golf Carts on city streets. All ayes, motion carried.

Motion by S Kelly seconded by J Erb to waive the 2nd and 3rd readings of Ordinance 2018-1. All ayes, motion carried.

Motion by S Kelly seconded by J Erb to approve the purchase of the CAT 420e backhoe from Eric Dale at a total cost of \$57,200 over 4 fiscal years. All ayes, motion carried.

Motion by S Kelly seconded by K Hinds to appoint Jonathan Erb as Mayor Pro Tem and

to add him to the signature card at the bank. S Kelly and K Hinds yes; J Erb abstain; motion carried.

Motion by S Kelly seconded by J Erb to approve the demo grant submitted by Mike Craig for 600 NW 6th Street in the amount of \$2500. All ayes, motion carried.

Motion by J Erb seconded by S Kelly to approve the increase in fees at the pool submitted by the Park & Pool Board. (Family pass \$130, Single Pass \$70, Daily Admission: Adults \$5 Students \$3) All ayes, motion carried.
