65.01 THROUGH STREETS. Every driver of a vehicle shall stop, unless a yield is permitted by this chapter, before entering an intersection with the following designated through streets.

(Code of Iowa, Sec. 321.345)

1. Poplar Street from South Fifteenth Street to South First Street.
2. Mill Street from South Third Street to North Tenth Street.
3. Q Street from South Fifteenth Street to North Tenth Street.
4. School Street from South Second Street to North Sixth Street.
5. Main Street from south corporate line to Northeast Tenth.
6. Church Street (U.S. 69) from South Second Street to the north corporate line.
7. First Street (Iowa No. 2) from west corporate line to east corporate line.
8. Lorraine Street from south corporate line to First Street.
9. White Street from South Third to North Tenth.

65.02 STOP REQUIRED. Every driver of a vehicle shall stop in accordance with the following:

(Code of Iowa, Sec. 321.345)

1. Hill Street. Vehicles traveling on Hill Street shall stop at South Second Street and North Tenth Street.
2. Locust Street. Vehicles traveling on Locust Street shall stop at South Third Street and North Tenth Street.
3. Poplar Street. Vehicles traveling on Poplar Street shall stop at South Tenth Street, North Tenth Street, North Fourteenth Street and North Fourth Street.
4. Mill Street. Vehicles traveling on Mill Street shall stop at North Seventh Street, North Tenth Street and North Fourteenth Street.
5. Q Street. Vehicles traveling on Q Street shall stop at North Seventh Street and Tenth Street.
6. Idaho Street. Vehicles traveling on Idaho Street shall stop at South Ninth Street, South Sixth Street, North Seventh Street and North Tenth Street.
7. Main Street. Vehicles traveling on Main Street shall stop at North Seventh Street, North Tenth Street and North Fourteenth Street.

8. School Street. Vehicles traveling on School Street shall stop at North Second Street, North Third Street, North Fifth Street, North Sixth Street, North Eighth Street and North Ninth Street.
9. South Fourth Street. Vehicles traveling on South Fourth Street shall stop at Vine Street.
10. South Third Street. Vehicles traveling on South Third Street shall stop at Locust Street and Vine Street.
11. South Second Street. Vehicles traveling on South Second Street shall stop at Vine Street.
12. North Second Street. Vehicles traveling west on North Second Street shall stop at Idaho Street.
13. North Third Street. Vehicles traveling on North Third Street shall stop at Idaho Street.
14. North Sixth Street. Vehicles traveling on North Sixth Street shall stop at Northeast Idaho Street.
15. North Eighth Street. Vehicles traveling east on North Eighth Street shall stop at North Oak Street.
16. North Eighth Street. Vehicles traveling west on North Eighth Street shall stop at Locust Street.
17. North Ninth Street. Vehicles traveling on North Ninth Street shall stop at North Oak Street.
18. North Sixth Street. Vehicles traveling west on North Sixth Street shall stop at Mill Street.
19. North Fifth Street. Vehicles traveling west on North Fifth Street shall stop at Mill Street.
20. North Fourth Street. Vehicles traveling west on North Fourth Street shall stop at Main Street.
21. North Second Street. Vehicles traveling east on North Second Street shall stop at Main Street.
22. South Second Street. Vehicles traveling east on South Second Street shall stop at Q Street.
23. South Second Street. Vehicles traveling east on South Second Street shall stop at School Street.
24. South Second Street. Vehicles traveling east on South Second Street shall stop at White Street.
25. South Second Street. Vehicles traveling west on South Second Street shall stop at Idaho Street.
26. South Third Street. Vehicles traveling east on South Third Street shall stop at Poplar Street.
27. Southeast Fifth Street. Vehicles traveling on Southeast Fifth Street shall stop at Southeast Idaho Street.

65.03 FOUR-WAY STOP INTERSECTIONS. Every driver of a vehicle shall stop before entering the following designated four-way stop intersections:

(Code of Iowa, Sec. 321.345)

1. Intersection of South Sixth Street and South Idaho Street.
2. Intersection of Church Street and First Street.
3. Intersection of North Tenth Street and North Poplar Street.
4. Intersection of North Sixth Street and North White Street.
5. Intersection of Northwest Sixth Street and Northwest Walnut Street.

65.04 YIELD REQUIRED. Every driver of a vehicle shall yield in accordance with the following:

(Code of Iowa, Sec. 321.345)

1. South Fifteenth Street. Vehicles traveling west on South Fifteenth Street shall yield at South Q Street.
2. South Fourteenth Street. Vehicles traveling east on South Fourteenth Street shall yield at South Mill Street, South Q Street and South Poplar Street.
3. South Fourteenth Street. Vehicles traveling west on South Fourteenth Street shall yield at South Mill Street and Q Street.
4. South Thirteenth Street. Vehicles traveling west on South Thirteenth Street shall yield at South Idaho Street.
5. South Twelfth Street. Vehicles traveling west on South Twelfth Street shall yield at Idaho Street, Mill Street and Q Street.
6. South Twelfth Street. Vehicles traveling east on South Twelfth Street shall yield at South Q Street, Mill Street and Poplar Street.
7. South Eleventh Street. Vehicles traveling west on South Eleventh Street shall yield at South Q Street and Idaho Street.
8. South Eleventh Street. Vehicles traveling east on South Eleventh Street shall yield at Mill Street, Idaho Street and Q Street.
9. South Tenth Street. Vehicles traveling on South Tenth Street shall yield at Idaho Street and Q Street.
10. South Fifth Street. Vehicles traveling west on South Fifth Street shall yield at South Oak Street, South Hill Street, South Vine Street, and South Poplar Street.
11. South Fifth Street. Vehicles traveling east on South Fifth Street shall yield at South Idaho Street, Hill Street, Vine Street, and Poplar Street.
12. South Fourth Street. Vehicles traveling west on South Fourth Street shall yield at Hill Street, Locust Street, Poplar Street and Idaho Street.
13. South Fourth Street. Vehicles traveling east on South Fourth Street shall yield at Idaho Street, Locust Street, Hill Street and Oak Street.
14. South Third Street. Vehicles traveling west on South Third Street shall yield at Oak Street, Hill Street, and Idaho Street.

15. South Second Street. Vehicles traveling on South Second Street shall yield at Mill Street, Locust Street and Poplar Street.
16. North Second Street. Vehicles traveling on North Second Street shall yield at North School Street, North Poplar Street and North Hill Street.
17. North Third Street. Vehicles traveling on North Third Street shall yield at North School Street.
18. North Fourth Street. Vehicles traveling on North Fourth Street shall yield at North School Street and Idaho Street.
19. North Fifth Street. Vehicles traveling on North Fifth Street shall yield at North School Street and North Idaho Street.
20. North Eighth Street. Vehicles traveling on North Eighth Street shall yield at Main Street, Idaho Street, Mill Street and Hill Street.
21. North Ninth Street. Vehicles traveling on North Ninth Street shall yield at Main Street, Idaho Street, Locust Street and Hill Street.
22. South Mill Street. Vehicles traveling north on South Mill Street shall yield at South Tenth Street.
23. White Street. Vehicles traveling north on White Street shall yield at Tenth Street.
24. North School Street. Vehicles traveling north on North School Street shall yield at Tenth Street and Thirteenth Drive.
25. North Main Street. Vehicles traveling south on North Main Street shall yield at North Thirteenth Street.
26. South Seventh Street. Vehicles traveling east on South Seventh Street shall yield at Mindi Street.
27. Northwest Walnut Street. Vehicles traveling north on Northwest Walnut Street shall yield at Northwest Sixth Street.
28. Northeast Eighth Street. Vehicles traveling east or west on Northeast Eighth Street shall yield at Northeast Q Street.
29. Northeast Ninth Street. Vehicles traveling east or west on Northeast Ninth Street shall yield at Northeast Q Street.

65.05 SCHOOL STOPS. At the following school crossing zones every driver of a vehicle approaching said zone shall bring the vehicle to a full stop at a point 10 feet from the approach side of the crosswalk marked by an authorized school stop sign and thereafter proceed in a careful and prudent manner until the vehicle shall have passed through such school crossing zone.

1. Q Street at Southeast Sixth Street and South Main Street at Southeast Sixth Street, or at such other point as shall be designated and marked by the Public Works Director and said Q Street between Southeast Sixth Street and Southeast Ninth Street, so as to best promote the health, welfare, and safety of the public.

65.06 SWIMMING POOL STOPS. At the following crossing zone, every driver of a vehicle approaching said zone shall bring the vehicle to a full stop at a point 10 feet from the

approach side of the crosswalk marked by an authorized swimming pool stop sign and thereafter proceed in a careful and prudent manner until the vehicle has passed through such swimming pool crossing zone:

1. South Main Street at Southeast Sixth and Southeast Ninth Street.

65.07 PARK AND RECREATION STOP. At the following crossing zone every driver of a vehicle approaching said zone traveling southbound shall bring the vehicle to a full stop at a point of 10 feet from the approach side of the crosswalk marked by an authorized stop sign and thereafter proceed in a careful and prudent manner until the vehicle has passed through such park and recreation crossing zone:

1. Southeast Poplar Street at Southeast Fifth Street.

65.08 STOP BEFORE CROSSING SIDEWALK. The driver of a vehicle emerging from a private roadway, alley, driveway, or building shall stop such vehicle immediately prior to driving onto the sidewalk area and thereafter shall proceed into the sidewalk area only when able to do so without danger to pedestrian traffic and shall yield the right-of-way to any vehicular traffic on the street into which the vehicle is entering.

65.09 STOP WHEN TRAFFIC IS OBSTRUCTED. Notwithstanding any traffic control signal indication to proceed, no driver shall enter an intersection or a marked crosswalk unless there is sufficient space on the other side of the intersection or crosswalk to accommodate the vehicle.

65.10 YIELD TO PEDESTRIANS IN CROSSWALKS. Where traffic control signals are not in place or in operation, the driver of a vehicle shall yield the right-of-way, slowing down or stopping, if need be, to yield to a pedestrian crossing the roadway within any marked crosswalk or within any unmarked crosswalk at an intersection.

65.11 OFFICIAL TRAFFIC CONTROLS. Every driver shall observe and comply with the directions provided by official traffic control signals at the following intersections:

1. Intersection of Church Street and First Street.
